OFFICIAL MEMORANDUM

Sub: Publication of Provisional Seniority list of Asst. Engineer Gr-1 pursuant to Honb'le High Court of Karnataka directions issued in Writ Appeal No.15216-225/2011 (S-RES) connected with Writ Appeal No. 17352-354/2011 (S-RES) dated 26-03-2021.

By the OM dated 02-05-1987, referred at 1 above, the appointments of 48 TFCs, appointed either on consolidated pay or daily wages during the years 1983, 1984 and 1985, were regularized prospectively from 15-05-1987.

01. Subsequently, by OM dated 27-05-1987, referred at 2 above, the appointment of Sri N Srinivasa Reddy was also regularized. In the OM dated 27-05-1987 his date of regularization was shown as 17-12-84 but his ranking is ordered to be fixed among the persons regularized in the OM dated 02-05-1987 between Sl. No. 40 [Sri SG Bulla] and S. No. 41 [Sri KV Mallesh] according to the length of service on consolidated pay/Daily Wages.

02. In the OM dated 20-03-1992, referred at 3 above, it was directed that the pay of Sri N Srinivasa Reddy should be fixed w.e.f. 17-12-1984, monetary benefit paid from 15-05-1988 and his seniority in the provisional seniority list of TFCs as on 31-03-1991 should be fixed between Sri S.K Kolhar [Sl. No. 9] and Sri T Ravi [Sl. No. 10]. Accordingly, his seniority was fixed at Sl. No. 9(a) in the OM dated 09-03-1994, referred at 4 above.

03. Subsequent to this, Sri Ramesh and others filed Writ Petition No.4705-4708/1999 and 19006/1998 seeking similar benefits as extended to Sri N Srinivasa Reddy. The Hon'ble High Court of Karnataka, by its order dated 07-02-2001, directed the Corporation to consider the representations of petitioners and pass appropriate order thereon etc.

04. The Corporation considered the representations, reviewed the entire matter of regularization of appointment of Sri N Srinivasa Reddy as TFC from 17-12-1984 and came to the conclusion that an error had crept in the process of his regularization.

05. The Corporation rejected the representations of Sri Ramesh and others in the OM dated 01-08-2001, referred at 5 above, on the following grounds:

"In the above stated circumstances the benefit of regularization extended to Sri N Srinivasa Reddy erroneously cannot be extended to Sri Ramesh and others. Hence the prayer of Sri Ramesh and others for regularization of their services with effect from their date of appointment and to grant all monetary benefits as granted to Sri N Srinivasa Reddy are hereby rejected."

06. Simultaneously, the Corporation by the OM dated 01-08-2001, withdrew OM dated 27-05-1987 and OM dated 09-03-1994 thereby nullifying the regularization of Sri N Srinivasa Reddy with effect from 17-12-1984.

07. On 17-08-2001 Sri Ramesh and others challenged the OM dated 01-08-2001 rejecting their claim in Writ Petition No. 32130/2001 before the Hon'ble High Court of Karnataka. But the same came to be rejected on 21-11-2001.

08. In the meanwhile, on 05-11-2001 Sri N Srinivasa Reddy challenged the OM dated 01-08-2001 withdrawing his regularization with effect from 17-12-1984 in Writ Petition No. 41212/2001 before the Hon'ble High Court of Karnataka. On 13-12-2001 an interim order of status quo was granted in this Writ Petition which was subsequently continued on 23-01-2002 until further orders.

09. On 03-01-2002 Sri S G Shivakumar and Sri Ramesh and others filed Writ Appeal Nos. 135-139/2002 challenging the order dated 21-11-2001 in Writ Petition No.32130/2001 of the single Judge. This Writ Appeal came to be dismissed for non-prosecution.

10. In spite of the ruling of Hon'ble High Court of Karnataka in the cases referred above, by an erroneous interpretation of the Order dated 07-02-2001 of the Hon'ble High Court of Karnataka in Writ Petition Nos. 4705-4708/1999 clubbed with Writ Petition

No.19006/1998 and after Corporation rejected their claim by the OM dated 01-08-2001, regularised the services of Sri.Ramesh, Sri.H.C. Prabhushankar, Sri.S.G. Shivakumar, Sri.Umesh N Patil & Sri.S.H. Eresime from the date of their appointment on Consolidated pay/Daily wage basis (ad-hoc appointment).

11. This regularization of Sri Ramesh and others was challenged by Sri N Srinivasa Reddy in Writ Petition No.15038/2005 before the Hon'ble High Court of Karnataka. This Writ Petition came to be disposed of on 13-07-2011 with a particular observation relating to the petitioner and the respondents, the relevant portion of which is extracted herein:

"6.12 In so far as the petitioner N. Srinivasa Reddy is concerned in Writ Petition No.15038/2005 his petition is hereby allowed but the disposal having the effect of denying the respondents therein of any advantage they may have gained ought not to be construed as accepting the position that since the seniority lists have attained finality it would no longer be possible to assail his ranking or that the corporation is estopped from making any correction. In other words, denial of the claim of the respondents does not have the effect of protecting his position, which is yet to be considered by the Gulbarga Circuit Bench in a pending petition. There is a specific observation of this court in its order dated 21-11-2001 in Writ Petition No. 32130-32134/2001 as regards the Corporation's stand of a mistake having been committed in his case and the same being sought to be corrected. Any such correction, if justified, would not be the same thing as disturbing the entire Seniority lists finalized year after year. However, in so far as his WP 12198/2009 is concerned is filed only on the ground that the impugned order is passed in the face of an interim order which was in force in a pending petition before the Gulbarga Circuit Bench in WP 41212/2001. This circumstance is not disputed. Hence, without will not decide any question that arises for consideration in the above pending case which shall be independently considered.

6.14 All other petitions are allowed and the respective impugned orders are quashed. It is declared that the respondent shall not adopt the initial date of entry into service on ad-hoc basis for purposes of seniority and shall hence recall any conditional orders made in favour of the several respondents."

The Hon'ble High Court of Karnataka allowed the Writ Petition of Sri. N Srinivasa Reddy thereby denying the benefits extended to the respondents, that is, Sri Ramesh and others but at the same time it is made clear by the Hon'ble High Court of Karnataka that denial of the claim of the respondents does not have the effect of protecting the position of Sri N Srinivasa Reddy which is yet to be considered by the Gulbarga Circuit Bench in the pending petition namely, Writ Petition No. 41212/2001. Further, correction in the case of Sri N Srinivasa Reddy would not be the same as disturbing the entire seniority lists finalized year after year. It is also made clear by the Hon'ble High Court of Karnataka that the initial date of appointment on ad-hoc basis shall not count for the purpose of seniority.

12. Respondents in WP 15038/2005 aggrieved by the same have filed Writ Appeal Nos. 15216-15225/2011 on 18-08-2011.

13. The Writ Petition No. 41212/2001, referred in para 8 above, filed by Sri N Srinivasa Reddy came to be disposed of on 10-04-2015 in terms of the order dated 13-07-2011 in Writ Petition No. 15038/2005, referred in para 11 above, however the same was made subject to the final orders to be passed in Writ Appeal Nos. 15216-15225/2011. Thus, the orders passed in OM dated 01-08-2001, referred in para 6 above, withdrawing OM dated 27-05-1987 and nullifying the regularization of Sri N Srinivasa Reddy with effect from 17-12-1984 stands, subject to final orders in Writ Appeal Nos. 15216-15225/2011.

14. On 08-06-2011 Sri N Srinivasa Reddy filed Writ Appeal No. 4191/2017 challenging the order passed on 10-04-2015 in Writ Petition No. 41212/2001 to the limited extent of "subject to the result of Writ Appeal Nos. 15216-15225/2011".

As per the Hon'ble High Court judgement W.P.No.9740/2005, Writ Petition No.9001-04/2005, W.P.No.15038/2005, W.P.No.10504/2005, W.P.No.25184-186/2001 dated 13-07-2021 Final Seniority list of Asst. Engineer Gr-1 (Civil) has been finalized by Official Memorandum No.KRIDL/ADM/TFC Gr-1 (SL)/2012-13 dated 30-04-2012, and subsequently final seniority list have also been published on 30-04-2015, 21-03-2017 and 11-10-2019.

In the meantime the Hon'ble High Court of Karnataka vide its order referred at (6) above has directed as follows:

"It is relevant to note that the W.P.No.41212/2001 filed by N.Sreenivas Reddy, was disposed off subject to the outcome of these Writ Appeals. Therefore, there is no impediment now to decide the entire controversy relating to fixation of seniority in the Corporation. In view of the discussions made in the above paragraphs, the services of N.Sreenivas Reddy shall be deemed to be regularized prospectively from the date of regularization and not retrospectively.

For the aforementioned reasons, the appeals are allowed and the impugned order of the learned Single Judge in W.P.Nos.9740/2005, Writ Petition No.9001-04/2005, W.P.No.15038/2005, W.P.No.10504/2005, Writ Petition No.25184-186/2001 is set aside.


In the result, the Corporation shall within three months from the date of receipt of a copy of this judgement, prepare and publish an provisional seniority list of Task Force Commanders including N.Sreenivas Reddy as on 20-06-1996, on the basis of the date of their entry into service. The Corporation shall, after hearing any objections received against the provisional seniority list, conclude the process of finalizing the seniority list within a period of three months thereafter. Until the aforesaid exercise is completed, the Corporation shall not publish any seniority list of Task Force Commanders or any promotional posts there from in the Corporation."

In view of the above foregoing paras, it has become necessary to prepare and publish the Seniority list of Asst. Engineer Gr-1 by considering the date of their entry into service. Therefore, a provisional seniority list of Asst. Engineer Gr-1 is prepared and published herewith for the information of all the concerned.

Any official aggrieved by the ranking assigned to him or to others in the Provisional Seniority list, may file his objection with supporting documents to the Managing Director, Karnataka Rural Infrastructure Development Limited, Bangalore-1 within 30 days from the date of publication. The objection should be specific and relevant to the ranking assigned to him or to any other person. The objections which are irrelevant in nature, will not be considered.

The Superintending Engineers, Executive Engineers and Asst. Executive Engineers should circulate this seniority list among the Asst. Engineers Gr-1 working under them and furnish the acknowledgements for having circulated the seniority list.


