Sub: Judgment dated 09.02.2017 of the Hon'ble Supreme Court in Civil Appeal No.2368 of 2011 (B.K.Pavitra & Others vs Union of India & Others) and also in accordance with. Govt. Order No. DPAR 182 SRR 2011 dated 06.05.2017- considering promotions for senior officials.

The Hon'ble Supreme Court in the Civil Appeal No.2368/2011-, i.e in B.K.Pavitra and other's Vs Union of India and other's case and rendered the judgment on dt: 09-02-2017 held that, "Karnataka Determination of Seniority of the Government Servants Promoted on the basis of Reservation (to the posts in the Civil Services of the State) Act, 2002 Section 3 & 4 which provides consequential seniority to those promoted under reservation is Ultra virus Articles 14 and 16 of the Constitution."

"In view of the above, we allow these appeals, set aside the impugned judgment and declare provisions of the impugned Act to the extent doing away with the "Catch up" rule providing for consequential seniority under section 3 & 4 to persons belonging to SCs and STs on promotions against roster points to be ultra vires Articles 14 and 16 of the Constitutions. The judgment will not affect those who have already retired and will not affect financial benefits already taken. Consequential promotions granted to serving employees, based on consequential seniority benefit will be treated as ad-hoc and liable to be reviewed. Seniority list may be now revised in the light of this judgment within three months from today.


In pursuance of the Judgment dated 09.02.2017 of the Hon'ble Supreme Court and based on the guidelines issued by the Govt of Karnataka in its GO Dated 06/05/2017 referred at (2) above, the seniority list came to be revised with effect from 24/07/1978.

Accordingly, a revised final seniority list in the cadre of Asst. Engineer Gr-2 came to be published by this office vide Notification dated 23-04-2018.

Therefore to implement the Apex court Judgment and circular instructions, the Departmental Promotion Committee met on 24-04-2018 and after considering the revised seniority list and ranking assigned to Sri.D.Gururaj, AE Gr-2, (HKDP) the Committee recommended the following official who is eligible promotion to the rank of AEE Gr-2 (HKDP) as follows.
